**AIMS AND OBJECTS:**

**THE MAIN OBJECTS TO BE PURSUED BY THE SOCIETY ON ITS FORMATION ARE :**

To develop young minds through scientific of learning and education and for purpose start or acquire and run schools, colleges, training institutions, day care centres and other similar avenues of learning.

To take over the school under the name and style St. Xavier's Public School which has been running as an Association of Persons at Kandakadavu, Chellanam with assets leased from Diocese of Alleppey.

To undertake any project or activity which in the opinion of the members of the society may be usually carried out by the society for furtherance of development of technology, management, applied arts, health and education.

To organize teaching and training process, conferences and lectures and similar other activities on the subject of theoretical, practical relevance on areas of technology, management, applied arts, health and education.

To publish journals, reports, pamphlets, book, booklets, research papers in furtherance of the object of the society.

To provide consultancy service under its auspices or through its faculty to Universities Central and State Government Institution/Organisations, International Organisations and other institutions or individuals.

To establish and maintain regional centers and subsidiaries to promote the objects of the society.

To purchase, take an lease or in exchange, hire, or otherwise acquire any movable and immovable property which may be deemed necessary or convenient for any purpose of the society.

To amalgamate with any institution, societies or associations having objects together or in part similar to those of the society.

(ii) To sell, lease, exchange or otherwise transfer any land, building or property or any assets and liabilities of the societies to any other persons, society, institution or company



1. To raise and borrow money, to purchase land, shares mortgage bills of exchange, promissory notes or other obligations or securities, founded or based upon all or any of the properties of the institutes with any security and upon such terms and conditions as the institute shall fit and proper and to pay from the funds of the institute all expenses that may incurred in raising funds of the society.
2. To draw, accept, endorse, discount and negotiate all types of bills of exchange, promissory notes and other negotiable instruments.
3. To invest the funds of the society in such bonds, certificates, securities or government Loans from time to time as it may be deemed necessary. To make such arrangements as the institute may think fit and proper for the benefit of the employees of the society.
4. To appoint, employ and pay agents or persons for any the purpose of the society.
5. To form committees, boards etc., for effective administration and for any purpose of the societies.
6. To institute, conduct, defend and compromise legal proceedings by or against the institute or its officers in respect of matters affecting the society.
7. To pay out of the funds of the institute or out of any particular part of such funds all expenses of land incidental to the formation and management of the society carrying out any of the forgoing objects including payments of salaries to persons employed by the society.
8. To generally do all such acts and things as are incidental or to conducive to attainment of the above objects of any of them as a charitable and non profit making organizations.
9. To accept donations and contributions for the futherance of the objects of the society.
